



TENNIS COURT POLICY & PROCEDURES

The policy and procedures exist for the purpose of maintaining the tennis courts and providing an opportunity for all to use them. Each resident is asked to cooperate, and to assist in enforcing these procedures.

Tennis Court Usage

1. Daily Operating Hours: 07h00 – 21h30 (subject to weather conditions and at Club's discretion)
The tennis facilities will be locked outside these hours.
2. A resident must have an active membership to use the tennis facilities.
3. The primary member, spouse and dependents will enjoy access to the tennis facilities.
4. Dependents under the age of 12 must be accompanied by an adult at all times.
5. Guests should be accompanied by a resident over the age of 16 when utilising the tennis facilities.
6. Reservations are recommended to avoid any inconvenience on the day you wish to play.
7. Residents may reserve court times two weeks in advance by calling Pearl Valley Clubhouse reception on (021) 867 8000.
8. Only one booking at a time may be reserved – no multiple advance bookings.
9. Tennis court time usage is limited to 90 minutes for singles and doubles play.
10. A player, or group of players, may use the court for only one playing period in succession. More than one period per day may be played, but not on a consecutive hourly basis, unless a court is vacant and has not been pre-booked.
11. The reserving resident must check-in at Pearl Valley Clubhouse reception prior to going on court. Courts will be assigned at check-in.
12. If you are not going to use a reserved court time, please call reception in advance so the court may become available to other players.
13. Court times will be held for 10 minutes after the scheduled time and then reassigned. Players who fail to cancel their reservation 4 hours prior to their scheduled court time or do not register 10 minutes prior to their court time may be charged a fee to be determined by the Club.
14. At the end of their playing period, players must promptly relinquish their court to the next players.
15. The practice wall can only be used when the tennis court is not booked.
16. Damage or maintenance issues should be reported at reception or security.
17. Use of the tennis facilities shall be subject to availability, weather conditions and seasonal maintenance.

General

1. Use of the tennis facilities is at the player's own risk.
2. Tennis facilities are exclusively for tennis play and practice and no other activities.
3. Dogs and other pets are not permitted in the fenced court areas.
4. Skateboards, bicycles, roller skates, roller blades and games other than tennis, are not permitted on the tennis courts or in the fenced area.
5. Sitting or leaning on the nets is damaging to the nets and net straps and is strictly prohibited.
6. Proper tennis attire must be worn at all times - soft soled tennis shoes only. Shirts must be worn at all times.
7. Pearl Valley Golf Estates is not responsible for the theft or damage of any personal property on the tennis courts while using the facility.
8. Proper tennis etiquette should be observed at all times. Excessive noise, racquet throwing or profanity will not be permitted at any time.
9. Trash and other litter must be deposited in the proper receptacles provided.
10. Glass containers are forbidden within the tennis facilities.
11. Hours of operation will be established from time to time by the Club.
12. The Club reserves the right to close the tennis courts at any time, without notice, for maintenance, weather conditions or any other reason deemed necessary or appropriate by the Developer.
13. Policies are subject to change without notice.

Please be considerate of others so that the tennis courts may be enjoyed by everyone entitled to use them.
